#### PURPOSE OF THE MINISTERIAL SCHOLARSHIP FUND

Scholarships have been created through the Christ United Jackson Ministerial Scholarship Fund to financially assist qualified men and women who are, or intend to become, full time pastors, missionaries, youth ministers, music ministers, church counselors or other similar full-time Christian workers ("Full Time Christian Ministry").

Christ United Jackson Scholarship Fund Committee ("The Committee") awards these scholarships to assist students in pursuing their seminary education. It is the desire of The Committee to be accountable to the donors and provide financial assistance to qualified applicants. In order to do this, guidelines and policies have been created to assist The Committee in its work.

### CRITERIA FOR AWARDING SCHOLARSHIPS

PLEASE CAREFULLY READ THE CRITERIA ESTABLISHED BY THE COMMITTEE AND COMPLETE THE APPLICATION. Once completed, the application along with all requested attachments and transcripts must be returned via mail no email or fax, NO LATER THAN JUNE 1, for the school year beginning in the fall, to:

#### INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.

- 1. Scholarships are awarded to deserving individuals who are preparing for, or actively engaged in full time Christian Ministry.
- 2. To be considered for a scholarship the applicant must have an overall college or seminary grade point average of 2.5, or above, on a 4-point scale and must maintain a grade point average of 2.5 or greater to be considered for additional funds.

- 3. The fully completed application form, along with applicant's current college/seminary transcript and the attached "Certificate of Church Membership" must be submitted to The Committee no later than June 1.
- 4. Scholarships are normally awarded only once a year, in or around July.

- 5. No scholarship will be awarded for more than one school year at a time. Therefore, a new application for a scholarship must be submitted for each new school year. The Committee is not obligated to award a scholarship to a previous recipient, regardless of the recipient's qualifications or grade point average.
- 6. Except in exceptional circumstances, all scholarship funds for an applicant will be paid directly to the seminary being attended by the applicant. The Committee may, however, in its sole discretion, based on criteria deemed by The Committee to be exceptional, submit scholarship funds directly to the applicant. In such cases, the applicant will be required to submit paid receipts for all expenditures of the scholarship funds along with such other information that The Committee may from time-to-time request. The Committee's decision regarding the recipient of the funds shall be final.
- 7. Scholarships are awarded only when The Committee, in its sole discretion, determines that sufficient funds are available. The Committee's determination of sufficiency of funds is final.
- 8. Applicant's pastor must submit to The Committee the completed "Certification of Church Membership" which is attached to and is a part of this application.
- 9. Applicants must also submit three written recommendations with the application for a scholarship. (Not from the same pastor that submits the "Certification of Church Membership.")
- 10. Applications will be received and processed using the following time frames:
  - a. Completed applications received by June 1 will be considered for the school year beginning in the fall.
  - b. The Committee will make every reasonable effort to review the application and notify the applicant of The Committee's decision no later than July 31.
  - c. When a scholarship for the school year has been awarded, The Committee will, upon receipt of an invoice from the seminary and other requested documents, mail the approved funds to the seminary within the time frame required.
- 11. All applications, recommendations, documents and material of every kind submitted to The Committee becomes its property, and The Committee is under no obligation to return the application, recommendations, documents, material, or any part thereof, to the applicant.
